### Terms of Use of the Site ("Terms of Use")

This website ("**Site**") and the products and services provided herein, are provided by China Unicom (Operations) Singapore Pte. Ltd. (hereinafter referred to as "**CUSG**", "**our**" or "**we**") or our representatives.

Users who access and/or use our services, products or information service through our Site (hereinafter referred to as "you" or "your"), shall comply with these Terms of Use and our Privacy Policy published on this Site (as may be varied or amended from time to time), when accessing and/or using our Site.

Please read these Terms of Use and our Privacy Policy carefully. By connecting, browsing, accessing and/or using this Site, you confirm that you have read and agree to be bound by these Terms of Use and our Privacy Policy (as may be varied or amended from time to time).

#### 1. Definitions

- 1.1 "Communication Service": refers to the communication functions you use through the communication network, such as telephone call, wide band Internet connection, etc.
- 1.2 "Customer Service": refers to the different kinds of customer service provided by this Site to you through the Internet, including but not limited to product experience, business processing, consumption inquiries, consultation, etc.

- 1.7 Unless otherwise stipulated in the context, when mentioned in these Terms of Use:
  - "person" includes natural person, business title, legal entity, cooperation relationship, joint venture enterprises, bodies incorporated or unincorporated, or other legal persons (including partnerships and their successors and assigns);
  - (b) "third party" refers to a person that is not a party to these Terms of Use;
  - (c) words denoting the singular include the plural and vice versa; and
  - (d) words such as "other, "including", "containing" or any similar expression do not limit the generality of any preceding words.

#### 2. Services

- 2.1 We will provide services to you on this Site in accordance with these Terms of Use and our Privacy Policy. Some of the services on this Site may be subject to further service terms. If such other service terms contradict these Terms of Use, the other service terms shall prevail.
- 2.2 Our Site provides Customer Services including but not limited to product experience, business processing, consumption inquiries, trouble report, consultation, etc. As we improve and update our Customer Services, we will correspondingly update this Site.

For the avoidance of doubt, nothing in this section shall affect the rights of any permitted assignee or transferee of these terms.

### 14. Other Matters

- 14.1 CUSG reserves the right, at its sole discretion, to change, modify, add or remove any portion of these Terms of Use, at any time. The modified Terms of Use will be shown to you when you log into the Site. It is your responsibility to read the modified Terms of Use. Once you access, connect, browse and/or use this Site, you accept and are subject to the modified Terms of Use. If you do not accept such amendments and/or modifications, you must stop accessing and/or using the Site. The modified Terms of Use will override the previous version.
- 14.2 If any part of these Terms of Use is held to be illegal, invalid or unenforceable, the illegal, invalid or unenforceable part shall be given effect to the greatest extent possible and the remainder will remain in full force and effect.
